What: Lee County pet license Pickup stray animals, Animal cruelty complaints, Nuisance domestic animals.
Who: If you and your pet (dog, cat, ferret) live in Lee County for 3 consecutive months, you must have your pet(s) licensed in Lee County. If not, you may face a fine.

How Much: License cost is \$25 if animal is unsterilized, \$10 if sterilized, \$8 if sterilized and micro chipped.

When: Within 10 days of making Florida your permanent residency (i.e.; registering your children in school, beginning employment, filing homestead status). If Florida is not to be your permanent residency, autos don't have to be registered in FL. (Migrant workers are exempt). Tax record information, registration of cars & boats, titles to vehicles & vessels, Fishing licenses, Handicap parking stickers.

**Why:** This is an affidavit attesting to Florida residency. It is useful when three legal forms of Florida residency are required (such as filing for Florida homestead exemption taxes), or for providing residency in determining what State(s) can access State income and death taxes, and which States' courts supervise the settlement of your estate, or for proving residency for colleges and schools.

**When:** If you own a vehicle, you must register it within 10 working days of becoming a Florida resident. You then have 10 days to acquire your Florida driver's license. If you don't own a vehicle, you must first sign an affidavit attesting to that before getting your Florida driver's license.

**How Much:** The fee for a new driver license is \$48 (Class E). There are two Lee County Tax Collector locations that provide limited driver license services. **Deposit:** The amount is based on a credit scoring system. A deposit can be equal to approximately 2 months average bill at the service address or waived. Deposits are refunded in full after 23 months of prompt payment or when the account is closed. There is a cash alternative to a deposit - an Unconditional Guarantee/Guarantor Contract, which is a legal document involving two parties. In order to be eligible for this non-cash deposit option, the Guarantor must meet certain criteria.

The EOC receives emergency information through the Emergency Dispatch Center and reports serious emergencies to the State Warning Point located in the State EOC in Tallahassee. They in-turn coordinate the State and/or Federal involvement or assistance within the County.

**Electronics Disposal:** Same day as regular garbage pick-up, place at curb separately from household garbage. Recycle: Residents are encouraged to minimize waste, reuse items and look for products that aren't overpackaged. Keeping recyclables oft of the regular garbage benefits the residents because less material is burned. Remember: more recycling + less garbage = cheaper garbage bills. **What:** School registration for Lee County occurs through the Student Assignment Department. **When:** Parents of students "NEW TO THE DISTRICT" or reenrolling should visit one of the Parent Information Centers to complete the student registration and school assignment process. Parents or guardians must show photo ID.

**Where:** Visit the website above to see what zone and sub-zone you reside in or parents can call (239) 334-1102 to find out which school their children will be attending.

**Documents Needed:** At the time of registration you must have all of the following documents to complete the registration process. Original birth certificate, Health examination (physical), Social Security card (if available), Florida Certificate of Immunization (original blue card), Proof of residence, Proof of custody is required if child is not living with both natural parents, Name and address of last school attended and a Copy of the I.E.P. - *This is just the basic information, more details may be found on the Student Assignment website.* 

\*if returning to the Lee County School District, you only need to provide immunization record, proof of residence, proof of custody (if applicable) and an I.E.P. if your child has one.

\*\*if entering the Lee County School District from another public or private school located in Florida you do not need a physical exam. All other documentation listed above is required.

When: As soon as you can prove your residency (i.e.; Drivers License, Declaration of Domicile)
Who: To Register You Must: Be a U.S. Citizen, Florida Resident, 18 years old (you may pre-register if you are 17), not now be adjudicated mentally incapacitated with respect to voting in FL or any other State, not have been convicted of a felony without your civil rights having been restored pursuant to law, not claim the right to vote in another county or State, submit your valid FL driver's license number of FL identification card number. If you do not have either of these, you must provide the last four digits of your Social Security Number.
To Vote: You must be registered at least 29 days before you can vote in an election. If this is a "new registration," the date a signed application is postmarked or hand delivered to your County Supervisor of Elections Office will be your registration date. If your signed application is complete and you are qualified as a voter, a registration identification card will be mailed to you.
